3. Rick Phelan – SCOE Assessment Results

Rick Phelan shared Kenwood School's assessment results for English Language Arts and mathematics for students in grades 3-6. The California Assessment of Student Performance and Progress (CAASPP) are computer based tests designed to measure subject knowledge, critical thinking and problem solving skills. Results were compared from 2015, 2016 and 2017. The new state accountability system is shifting away from a single point of accountability based on test scores to multiple measures.

Mr. Bales reported PLT (Personal Learning Time) has concluded. The kids enjoyed this new learning experience.

Momentum in Teaching, a new K-6 writing program is under consideration.

Most of the formal teacher observations have been completed.
